Pool petition tabled

A pair of High Street restaurant owners took a timely cue from the License and Franchise Committee Monday, agreeing to resubmit in September their petition for a pool table, giving the council more time to consider it.

Hector and Samuel Contreras, owners of Paisano, Guatemalan restaurant across from Calvary Cemetery, had applied for a license to install a coinoperated pool table on the premises. The brothers opened their restaurant a month ago, replacing Buckaroo's Barbecue, which in turn replaced Patty's Donuts.

Committee chairman Paul J. Brasco said the request has a good chance of success, but it faces opposition from some other councilors.

"This council knows that a good rule of thumb is pool sticks and alcohol don't mix well," said Council Vice President Thomas J. Curtin.

Council Vice President Thomas Curtin said Pulte is in compliance with its special permit. and the side-
